

Who is Eligible

Applicants must:

- 1. Have a bilateral contract for purchase of a primary residence in St. Lucie County
- 2. Be employed or show verifiable income
- 3. Have a certain qualifying income level as outlined in the application.

WHAT IS **ATTAINABLE HOUSING?**

Easy Application Process

- Applicants must inform their lender and Realtor® of interest in the Attainable Housing Program.
- Visit our website www.Rworld.com/foundations under Attainable Foundation select Download **Application**
- Complete application with all necessary supporting documents and submit to our Treasure Coast Office
- Application must be received by the Association staff at least 21 business days prior to closing. Late

submittals may be automatically denied.

What's Next?

- Review of Application by Foundation's Staff
- Eligible applications submitted to Foundation's Board of Directors for final approval
- Applicants will be notified of Foundation's
- Awardee will receive funds typically during the closing and are dispersed to the lender
- Grants are NOT given directly to Grantee
